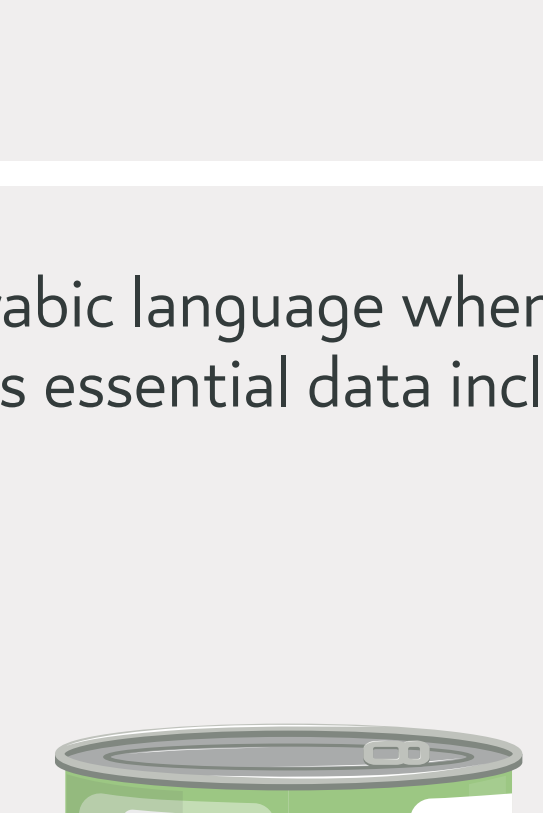

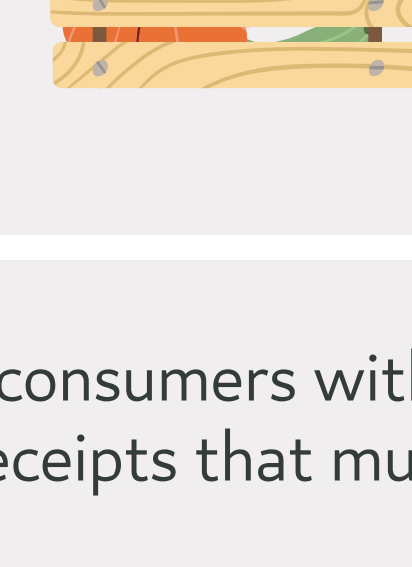

## Merchant's duty towards Consumers:

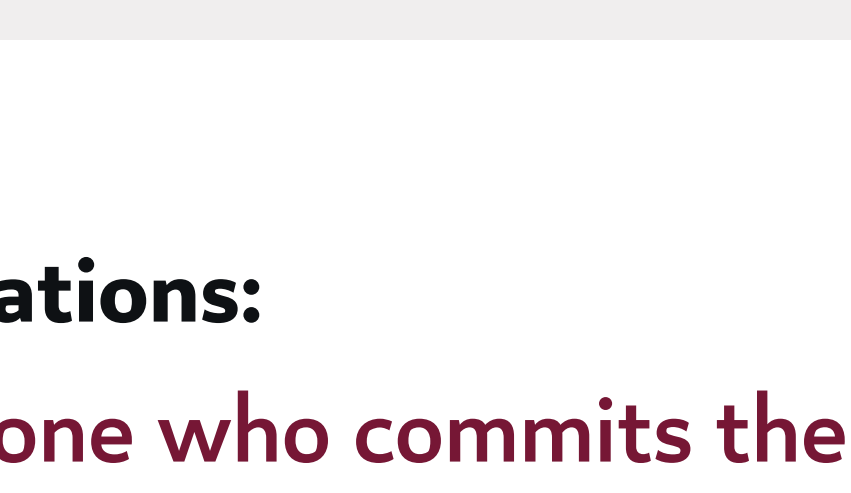
Display the daily newsletter of fruits and vegetables prices clearly in the store.



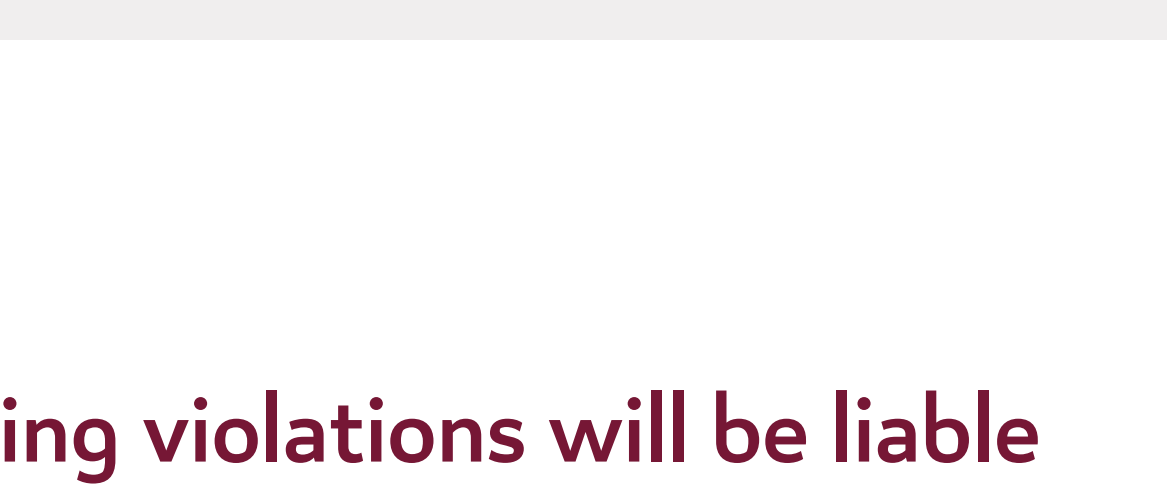
Separate local from imported fruits and vegetables in the daily newsletter.



Adopt Arabic language when displaying items essential data including:

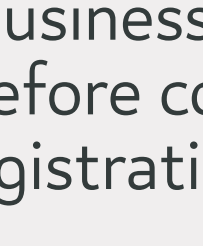


Provide consumers with detailed receipts that must:

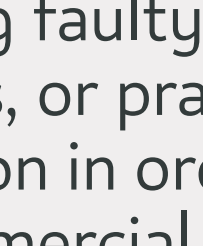


## Violations:

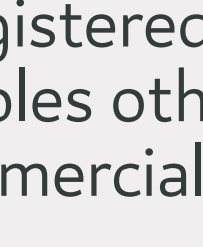
Anyone who commits the following violations will be liable to a fine of 200.000 QR:



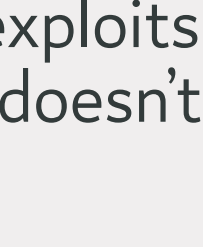
Starting a business or establish a store before commercial registration.



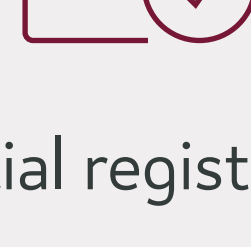
Submitting faulty data or fake documents, or practicing fraud or deception in order to obtain a commercial register.



If a person registered in commercial register enables others to exploit the commercial register.

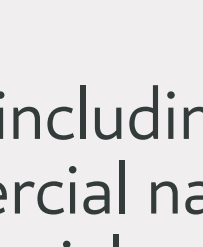


If a person exploits a commercial register that doesn't belong to him.



If mentioning a commercial register despite not having one.

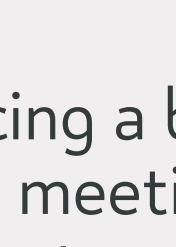
Anyone who commits the following violations will be liable to a fine of 50.000 QR:



Not including the commercial register in Arabic on the store signboard, and all the store correspondence and publication letters related to trade.

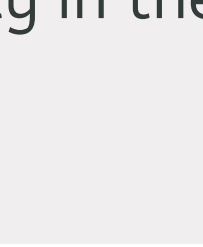


Establishing a store and running it without obtaining a commercial license.

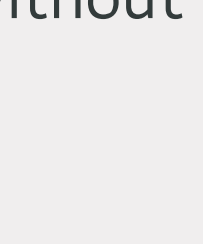


Practicing a business without meeting public and private conditions according to the business and preparing the store before obtaining the required approvals from competent authorities.

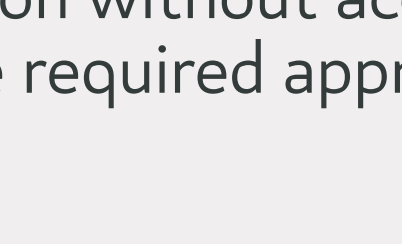
Anyone who commits the following violations will be liable to a fine of 10.000 QR:



Practicing an additional activity in the store.



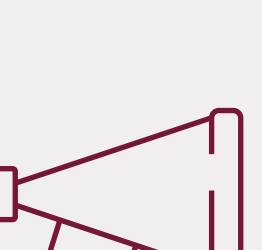
Modifying the licensed store without approval.



Changing the store location without acquiring the required approval



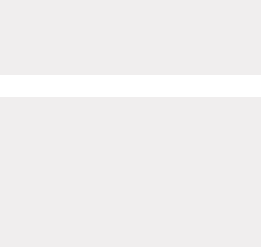
Not hanging the commercial license in a visible place or not presenting the license to competent authorities.



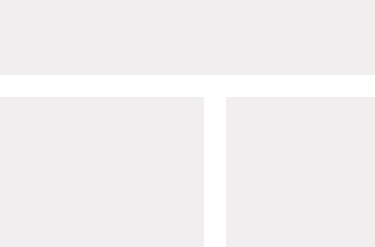
Not hanging an introductory sign on the storefront.



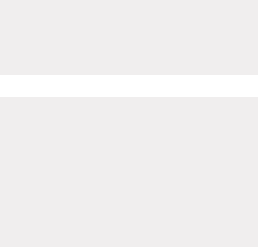
Lacking the controls set by competent authorities on the storefront.



Not removing the signboard if the license is canceled or the business is closed.



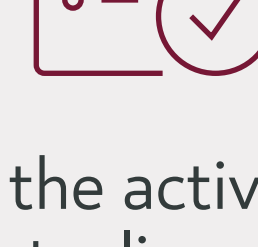
Advertising a store subject to provisions of this law by any mean unless a copy of valid license is submitted.



Abdicating a license before obtaining a written approval from competent authority.



Practicing the activity of street vendor before obtaining the required license.



Practicing the activity of street vendor without a license is prohibited.



**If a licensed street vendor commits the following:**

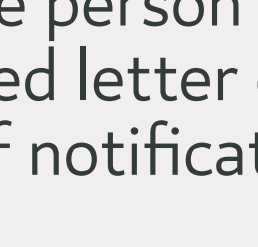
- Not holding the license issued by competent authority.
- Not presenting the identification card received by competent authority in a visible way while practicing the activity.
- Not presenting the license to authorized people upon request.
- Not returning the identification card to the competent authority if license is canceled or business is closed.



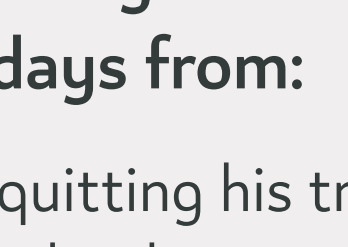
**A street vendor is prohibited from the following:**

- Stalking people to show or sell goods, or services.
- Practicing the activity near schools, education centers, hospitals, health centers, or unlicensed places by wandering through them or near shops that practice the same activity or inside transportation vehicles.
- Announcing the activity by calling or using bells, or any disturbing means.
- Selling or displaying fireworks, or any prohibited toys.
- Announcing the activity by calling or using bells or amplifiers, or any other disturbing means, or practicing the activity other than the specified times.

Anyone who commits the following violations will be subject to entry deletion from commercial register:



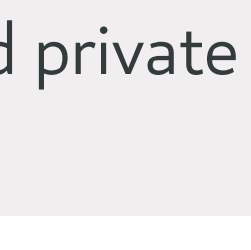
Not submitting renewal request within 90 days from the date of warning the person concerned by a registered letter or any mean of notification.



**If the person concerned does not submit an entry deletion request within 30 days from:**

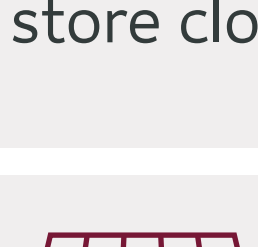
- Merchant quitting his trade.
- Merchant's death.
- End of legal person liquidation.
- Legal person quitting for any reason.

Administrative closing of the shop will be applied on the following violations:

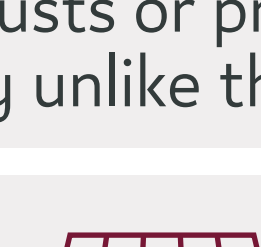


Violation of general and private requirements for stores.

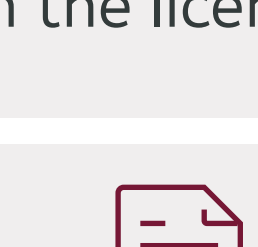
Cancellation of license for shops with the following violations:



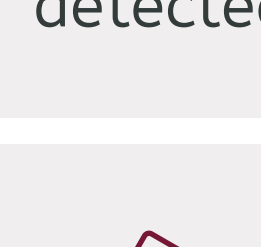
If the licensed person notifies the department of Registration and Licenses of store closing.



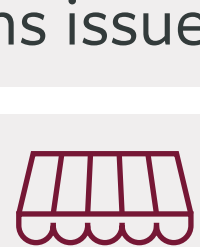
If the licensed person without approval of department of Registration and Licenses- adjusts or practices another activity unlike the license.



If the store is inoperable or does not meet the conditions contained in the license.



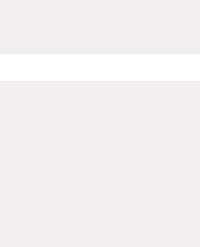
If a public health hazard is found or acts contrary to public morals are detected.



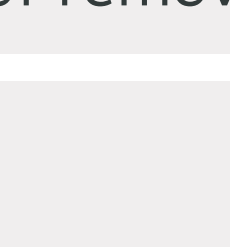
If a new owner does not notify the department of Registration and Licenses about transfer of ownership, according to the provisions of the law and the decisions issued for execution.



If a final verdict to cancel the license is issued.



If a store stops working for 120 days, without a reason accepted by department of Registration and Licenses.



If the property on which the store is located is removed, and the store is not relocated with approval of department of Registration and Licenses, within 120 days of removal date.



If a licensed person proved to obtain the license based on incorrect or nominal data.

Cancellation of license for shops with the following violations:



If a street vendor loses any of the requirements to obtain the license.



If incorrect documents or data are submitted to obtain a license.



If unauthorized activity is practiced.



If enabling another person of using the identification card.
